The Third Step and Your Prayer

Made a decision to turn our will and our lives over to the care of God as we understood him.

This statement follows the Third Step Prayer on page 63 of the Big Book: "The wording [used for the prayer to affirm our "3rd Step Decision"] was, of course, quite optional so long as we expressed the idea, voicing it without reservation."

Some of our founders and early members of the fellowship used a prayer other than the one on page 63 of the Big Book to take newcomers through their "decision" — namely because the Big Book wasn't printed until 1939 and they got our Program from Oxford Group principles. Bill W., Dr. Bob, and Bill D. started making 12 Step calls and taking others through the original 6 "steps" in the summer of 1935.

Here are a couple examples of "3rd Step Prayers" used by our early members:

THIRD STEP PRAYER used by <u>Dr. Bob</u>

Dear God.

I'm sorry about the mess I've made of my life. I want to turn away from all the wrong things I've ever done and all the wrong things I've ever been. Please forgive me for it all. I know You have the power to change my life and can turn me into a winner. Thank You, God for getting my attention long enough to interest me in trying it Your way. God, please take over the management of my life and everything about me. I am making this conscious decision to turn my will and my life over to Your care and am asking You to please take over all parts of my life. Please, God, move into my heart. However You do it is Your business, but make Yourself real inside me and fill my awful emptiness. Fill me with your love and Holy Spirit and make me know Your will for me.

And now, God, help Yourself to me and keep on doing it. I'm not sure I want You to, but do it anyhow. I rejoice that I am now a part of Your people, that my uncertainty is gone forever, and that You now have control of my will and my life. Thank You and I praise Your name. Amen.

THIRD STEP PRAYER used by <u>Clarence Snyder</u>.

Office Manager Report 1/25/12

As we review what our Intergroup has accomplished not only in 2011 but through the years with the support and dedication of those who love AA - our Trusted Servants, scores of volunteers and the Intergroup Staff, we can feel confident that we are indeed providing the services needed in our community.

One of the highlights of 2011, is this Steering Committee prepared and presented the SPBC Intergroup revised By Laws that now include the principles of the Right of Decision, the Right of Participation and grant Authority to match responsibility which is directly from our AA Concepts.

SPBC Intergroup is a 501C3 Corporation which entitles us to Tax Exemption on purchases, relieves us of paying taxes on our Income. With our annual Gross Revenue of just over \$200,000 last year (Actually \$208,201 to be exact), this is, of course the prudent and practical method of protecting the "business" of our Intergroup office so we can continue to fund AA services to those in need. Our Intergroup Office Manager prepares, files and pays all required taxes in a timely manner, and we follow the laws of our state and our federal government in all tax regulations. Our Inventory Assets (paid inventory) at the end of the year was \$25,640. We offer over 20 opportunities for service at our office every week – and these volunteers answer the AA phones and are in charge of 12th Step work. Some of our volunteer staff assist with the sales and other duties as well. We are all on janitorial detail. Through your support of time and contributions we can keep our doors open and provide the vital services of AA available to anyone asking for help. Our co-founder Bill refers to Central Offices & Intergroups as the "frontline of AA", and we are all responsible to keep these doors open.

As your Office Manager, it is my responsibility to report to our Officers not only the status of our services, but our cash flow on a monthly basis. Through the past year, as we have been reporting to you each month, the Contributions have not supported these services and we must rely on our Net Sales income and special events which raise funds for our Intergroup office. We were able to support our projected budget for 2011, but our Prudent Reserve of \$28000 is short. Therefore I have made several suggestions to our Officers to determine what we can do if the Contributions do not begin to cover our regular monthly expenses.

The most costly expenses are our Rent and our Payroll Expenses:

- We moved into our current location nearly 5 years ago and we pay a fair rent for this area. I have done some research on other rental properties that will continue to offer 1st floor space (which is essential for AAWS deliveries by truck); a centralized location for our groups; and room to provide space for committees, volunteers and visitors; plus we intend to attempt negotiations with our current landlord, however the rent we pay is fair for this area.
- Our Payroll expenses increased over a year ago when three things happened:
- I received a raise in January 2011 the first in several years, that not only gave me additional salary but also a vote of confidence from this Intergroup that after years of stagnant wages I would begin to receive a fair wage for the job I do.
- It was approved for me to hire a Full Time Assistant following years of Part Time employees that did not work out; and my announcement to this body that I could no longer work over 40 hours per week.
- And the Federal Government placed a penalty on Florida charging each and every employer additional Fica payments. (which continues today)

Other than the PR Taxes, this was all outlined in our 2011 Budget last year. No one objected at that time. Now that the Contributions have not paid for this Budget there seems to be a sudden interest in our Intergroup, and for that I am

grateful. Hopefully this will bring new volunteers to assist us at the office and on the committees.

We are hoping that this Survey handed out tonight will help us to accurately assess our situation going forward. We need your assistance with this and request that you pass these out; fill them out; go to the website and print them out . If we work on this together, we can achieve the results that you and your groups want and are willing to support.

In February at the Steering Committee meeting, I will be presenting options to my Officers that may need to be considered at least in the short term. Just as our General Service office manager, Phyllis, needed to make temporary employment adjustments in 2010, I will be looking at and providing suggestions to my officers to reduce the payroll costs if necessary. Any member of AA can ask to see this report, or make suggestions and I welcome the assistance of experienced business people and constructive criticism.

Finally I would like to mention that I learned early on in my employment with an Alcoholics Anonymous service office that NONE of the problems or questions that come up are new or original, and the answers are always in our literature if we look for them. My work experience and work ethic can run an office; but my opinion does not matter when it comes to running an Intergroup office – the words of experience from those who have been on the Frontline of action does matter.

The basic analysis is that expenses exceed net income and we need to find a way to either cut costs and/or increase our income. Any and all suggestions are welcomed. Archives: Nick L. In January, District 8 held the annual Archives Winter Workshop which included a slide show presentation of the General Service offices in New York City.
